Vestry Roles and Responsibilities

- Carolyn facilitated a working session about how Vestry connects to areas of Mission and the four missional areas: Fellowship, Education, Worship and Community. This work will continue at May Vestry
- Michael's has consolidated summaries from the four guiding documents for Vestry roles and responsibilities: baptismal covenant, CEC Bylaws, CEC Covenant of Call, Canons of the Diocese of Michigan

Other Business

- Finance Update Kevin Green
 - Offering Plate Income and Total Income were over budget for March.
 - Expenses were below budget.
 - These improvements against budget resulted in a monthly deficit of \$2,090 versus a budgeted deficit of \$5,497.
 - Year to Date, we are approximately \$500 better than budget (\$17,720 deficit versus \$18,270).
 - In the April reports, we will be correcting the amounts in Plaza, Rector Discretionary and Restricted Gifts/Payments due to some funds being moved among those accounts incorrectly.
 - April started very strong (but last week was very weak due to the weather) and April income will most likely exceed budget because it will include 5 Sundays, including Easter.
- Curate update Terri Pilarski
 - Terri read from a note from Halim Shukair thanking CEC for the opportunity to meet with Vestry and parishioners
- Music Advisory Team update Diana Brehob
 - Additional members will be added to the team (along with Diana, Terri and Selia)
 - The target is to advertise the position in early Fall
 - The vision for the role will inform discussion of budget needs and the current intent is to advertise a position in the Fall
 - Funding of choir room updates make request to Property (building improvements)
 - Diana highlighted that without an experienced organist it is difficult to identify teething troubles with the organ
 - Substitute musicians have been arranged for most Sundays through end of the summer
- Earth Day Terri Pilarksi
 - Carolyn will review two documents on environmental impact and stewardship:
 - Opportunity for energy assessment and review with Consumers Energy
 - Michigan Interfaith power & light
